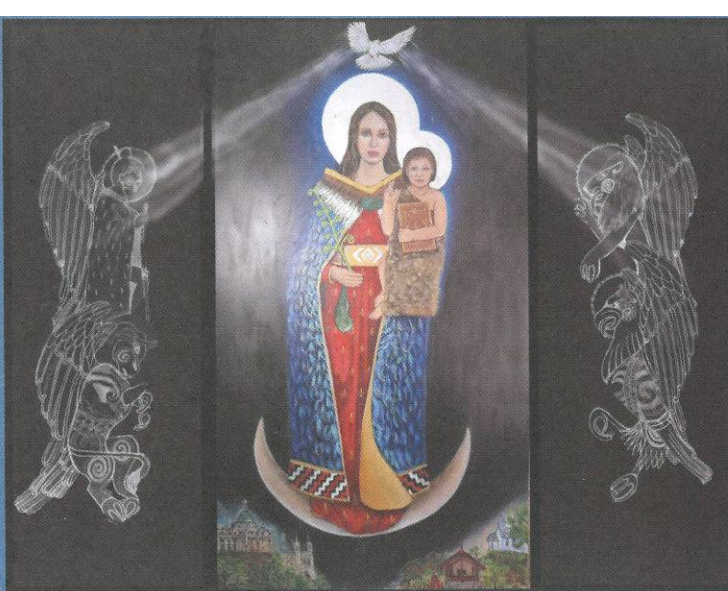

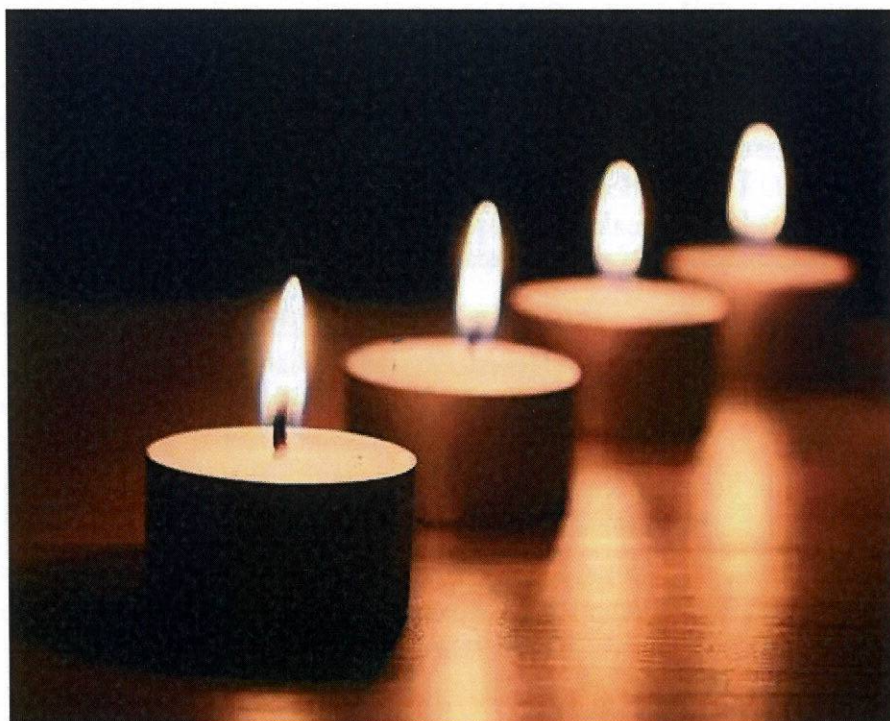

Report of the Revenue Subcommittee
Presented to Fr Kevin Mowbray, SM, Parish Priest
On behalf of the Parish Pastoral Council
October 2023

Earlier this year the Parish Pastoral Council (PPC) tasked this Revenue Subcommittee with researching whether the Parish can continue to pay its natural disaster insurance. This Subcommittee has concentrated its effort on finding options for how the Parish can increase existing funding and how it might develop new sources of revenue to achieve that aim. The Subcommittee has focused its discussions exclusively on increasing revenue, rather than decreasing expenses, because the largest annual expenses are mostly fixed, and are outside of our control.

As well as looking at Parish revenue, and how that might be improved, the Subcommittee accepted that not all revenue donated to the Parish stays in the Parish. Each year we are asked to show our solidarity with the Archdiocese by financially contributing to programmes that might otherwise lack sufficient funding. This contribution is a necessary part of our mission, in communion with our wider Catholic community. It is important that parishioners recognise this is not a burden, but simply necessary under the norms of our Church.

The Subcommittee has considered a range of options from small-scale fundraising ideas to large events. It has looked at better utilising our facilities at St Mary of the Angels and St Joseph's (e.g., naming the new parish hall and marketing this as a venue for corporate meetings or functions; additionally, advertising more widely and proposing the church venues be available for more concerts, but which respect the special nature of the churches). It has looked at employing modern technology to make payments and donations easier (e.g., greater use of QR codes or enabling payees to 'Tap' or 'Wave' their card over a card-reader to make contactless payments). All these initiatives require effort and need to be undertaken with a degree of commercial acumen and a level of thoughtfulness about how to ensure that well-intentioned ideas do not create an unreasonable administrative overhead or produce unintended consequences.

Many of the ideas require willing volunteers to lead and support the various initiatives. It was felt that the Parish administration should not be expected to take on this added responsibility. Those undertaking this work should be suitably experienced to successfully undertake such tasks. The deployment of modern technologies, for example, needs to be carefully researched as important questions addressing security and privacy risks need to be considered before deployment. When running events, particularly large fundraisers, reputational and financial risks need proper consideration with formal governance oversight, provided by either the PPC or the Finance Committee. Coordinating all this will also require additional effort.

In this brief report you will find on Page 2 a summary of the range of ideas tabulated with estimates of potential revenues and explanatory notes. It is intended that this can be used as a four-year plan of what is potentially achievable. It should be seen as a call to action for the various Parish groups and interested individuals to lead initiatives that they wish to help bring into fruition. Page 3 provides the recommendations formally made by the Subcommittee to the Parish Priest to discuss and progress, with the support of the PPC.

The Table below shows a revenue forecast for the next four years.

This is shown in calendar quarters, with Q1 being Jan-Mar, Q2 is Apr to Jun, Q3 Jul to Sep and Q4 Oct to Dec. The dollar amounts are rough estimates of revenues, after costs presented in thousands of dollars. They are illustrative of what could be achieved and are, apart from a few exceptions, not a fully costed plan for each of the initiatives. The assumptions around what funding attracts Archdiocesan levies (listed as Arch at the bottom of the table) is based on whether the initiative provides an ongoing Parish revenue, or whether it is an initiative dedicated to a specific cause, such as the upkeep of the church buildings. That means the regular, smaller initiatives tend to attract levies, while many of the larger ones do not.

Approach

Ideas for revenue were captured, assessed and grouped into categories., depending on the level of effort involved, the revenue they might create, whether they attract levies etc. This work showed there are many possible ideas, but it became clear that each initiative requires a leader to progress it, with a willing group of supporters to assist. Seed funding is limited, so if that is needed that may be obtained by running movie nights or other similar activities, rather than relying on this being made available from Parish funds. It is expected that before approving any revenue-gathering initiatives the Finance Committee and/or the Parish Pastoral Council would need to make ensure it has a sound financial plan and suitable controls around risks.

Smaller Scale Initiatives.

These could be initiated by individuals or groups. Initiatives 2, 4, 5 and 7 are being progressed by members of the Revenue Subcommittee. In doing so it has been found that there are several practical questions that need to be answered before each of these can be progressed. It was thought that it would be prudent to coordinate such activities, to make sure they are all delivered to best effect. For example, QR codes are already being to be used, however, to make best use of technology, Item 6 will also need to be looked at. This is so that the processing of Payments or donations using credit or bank cards are just as convenient as they are on donor sites such as Give-a-Little, including the issuing GST invoices or IRD-compliant donor receipts.

Large Initiatives or Projects

Volunteers are also needed to undertake specific work for much grander events. The effort required of such events would likely involve considerable effort, by larger teams of people needing specialist skills. Because these types of event have a high-profile component, there is always an element of reputational risk, if not managed correctly. Therefore, the level of governance over such activities would likely need to be greater than the smaller initiatives. The level of effort is currently being gauged by progressing with Initiative 8. The Parish, over the years of fundraising, has developed a good level of expertise in running such events. This will help as we consider the sorts of events would be most appropriate for the Parish, as well as the timing of such events, to ensure these are spaced out throughout the year.

Initiatives not considered

The remaining initiatives would benefit from further investigation but were not discussed in detail by the Subcommittee or included in the revenue projections. Item 13 is an option, for example, but our churches are consecrated spaces and need to be treated with a level of reverence. If hired as venues, then the activity conducted within them must also be appropriate and fitting to take place within a church. Initiative 14 was something that could occur on an annual basis, ideally at the same time the previous year's financial reports are presented. Items 15, 16 and 18 would require a dedicated effort and would work best for a specific cause, rather than covering operational expenses, such as insurance premiums. Finally, Initiative 17 would work best only if the Parish Centre was operating as a public venue, so donors can be publicly acknowledged.

Parish Projects and Programmes

Both Parish communities have both physical buildings and programmes that would benefit from funding by additional revenue. In the past heroic efforts have been made to build, strengthen and refurbish the various Parish buildings, as well as to support missions or programmes that are important for us as a community of Christians. The needs for conducting fundraising, for whatever causes or needs, are seemingly limitless. Therefore, it is necessary to acknowledge and prepare ourselves for utilising our time and talents in providing treasure for the benefit of building a sustainable, mission-focussed community, centred around our churches.

Recommendations:

It is recommended that:

The Parish Pastoral Council consider this report and its recommendations and take the lead in ensuring that revenue generation is maintained as a line of effort within the Parish community, in order that the Parish maintains a financial surplus to ensure a sustainable future.

1. The Parish cannot rely on targeted fundraising to cover the increasing costs of natural disaster insurance. Such a level of fundraising is unsustainable, so natural disaster insurance should be discontinued.
2. The PPC should establish a permanent Parish group tasked with raising revenue by implementing the ideas outlined in this report and coordinating the revenue generation efforts of the Parish.
3. The Parish Finance Committee should regularly provide updates on the state of the Parish finances, so that parishioners may increase their planned giving and make up any operational budget shortfalls throughout the year.

The Parish Pastoral Council should note that:

- a. While the Parish has been successful in raising funds for building projects in the past, the ongoing shortfalls in revenue to cover all existing operating expenses, including those for ever-increasing natural disaster insurance of St Mary's church, will require sustained revenue-gathering effort. However, volunteers and donors also have their limits, so considerations of donor fatigue need also be kept in mind, but the coordination of fundraising efforts by a single group will help mitigate this risk.
- b. Concentrating fundraising efforts towards providing funds for Parish-based or Archdiocesan expenses or ministry is likely to yield stronger support and provide a greater sense of community rather than making payments to insurance companies.
- c. It is the view of this Subcommittee that a substantial and permanent uplift in planned giving is needed to provide a for the needs of the Parish. Fundraising and revenue generation should be seen not just as a strategy for generating funds in addition to the basic operating needs of the Parish, but rather a tool for prompting missions, activities or Church groups.
- d. In making these recommendations it is appreciated that our churches, the centers of our community worship, although architecturally significant for our city, will likely not be able to be rebuilt following a cataclysmic event. That should therefore perhaps be made clear to authorities including central government agencies and local authorities, by either the Parish or more properly by the Archdiocese.

Conclusion

The Subcommittee has progressed some of the ideas outlined within this report. This was done to test the initiatives and build momentum in the ongoing effort to raise funds. It is now up to the Parish to more actively undertake fundraising. By harnessing the skills and talents of parishioners, planning, and promoting initiatives, including an increase in planned giving, the Parish can develop a sustainable future for our community for generations to come.

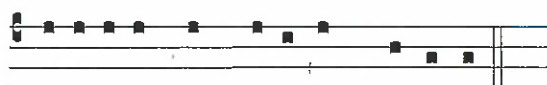

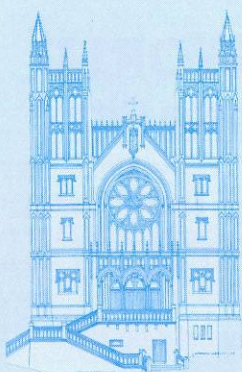
St Joseph's Working Bee - 8.30am Saturday 2 December

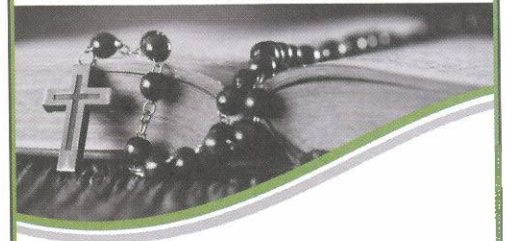
